The Chairman's Report for 1951

TO be elected Chairman of this Club, which has such excellent traditions behind it, is indeed an honour, but to follow in the footsteps of such eminent Chairmen as The Rt. Hon. Lady Howe and Mr. R. R. Kelland is something of an ordeal, but I will do all in my power to maintain the Club's position. Having served as Vice-Chairman to both the previous chairmen, has prepared me for the task, and I ask for the members' tolerance and forbearance for my shortcomings.

In Mr. R. R. Kelland the Club is particularly fortunate in their President. His knowledge of the breed extends over many years and his experience of the Springer as a shooting dog second to none. His many years of assistance to the Club have been of the utmost value, and a glance at the present enviable position of the Club and the breed is eloquent testimony to his work, and the great support given to the Field Trials by Springer folk has kept the breed prominently in the forefront as a utility gundog.

During the past year the breed has maintained the steady unspectacular progress which is far more lasting than the flash in the pan rise witnessed

in some breeds. A great win was recorded at Manchester Championship Show when a Springer was returned the Supreme Champion.

Summing up the situation of the breed, one can report that the entries both at trials and shows have been well-maintained and many new converts in both fields have been made.

On the whole the Springer, now generally speaking, is being produced much nearer the Club's standard than ever before; the "Settery" and "Pointing" types are now rarely seen, and the true Spaniel has come into its own. To cast an eye over a representative entry at a Championship Show to-day is a real pleasure to lovers of the breed. Gone is the gooseberry-eyed specimen so prevalent a decade ago, the huge leggy specimens are relegated to their right position and the neat symmetrical dog reigns in their stead, a matter for congratulations to all concerned. Size has become much more even, but there still remains plenty of room for improvement in spring of ribs, strength of loin and depth of brisket, all essentials for a dog designed to do a hard day's work. This is not beyond the ability of breeders to rectify, and it is

hoped that next year will see this more prominent in the best specimens.

The Club is most fortunate in its real office bearers; Mr. Roblin as Hon. Treasurer has no equal in this office, and in Major and Mrs. Travers in their position as Hon. Secretaries, the Club is indeed fortunate. It must be gratifying to the members that this team have accepted office for another year. The thanks of members to Miss Morland Hooper are also due for the able way she managed the Field Trials.

Your Committee are keen and enthusiastic and everything points to continued progress, but here again progress can only be obtained by all pulling together, both to keep the membership up and expenses down. No club should endeavour to function merely to obtain a large bank balance,

but a large bank balance is essential to maintain the breed at the top and give the members all the privileges of membership. Administration expenses have increased enormously of recent years, particularly in postage and printing, and without ever-increasing membership the enviable position as the leading National Springer Club cannot be maintained.

The Club owes a debt of gratitude to the Press, who are ever willing to assist in publicity, without which no club can progress.

The members are a sporting crowd and all seems set fair for a record year provided all continue to work together and not relax their efforts for the breed.

In Memory of the late President

IN the person of Capt. O. P. Traherne the Club mourn a great President, a great sportsman and one of the greatest advocates of a Springer that ever lived. During his term of office the breed made immense progress in the Field Trial world, and through his influence and ardour the English Springer became ever more popular in America, where undoubtedly he was looked upon as the first choice in gundogs.

Many were the good ones of the breed this gentleman bred or owned, but it was in 1924 that the power of the "Bryngarw" prefix burst on the trial world with full vigour. Many field trial champions ran in his ownership, always piloted by his faithful handler, Mr. W. Church, whom he always honoured as a great comrade and at Mr. Church's death his interest in trials and workers began to wane.

Few owners ever owned such a wonderful lot as F.T. Champions Bryngarw Coloraine, Jock, Firefly, Firearm and Firelight. It is claimed that considerably more than forty Single Stakes were

won by the Bryngarws and with Brace and Team events the total must approach the hundred.

Capt. Traherne was numbered amongst the very select band of Englishmen who were invited to judge the American Field Trial Championship. A man of great culture and very simple homely tastes, he was inordinately proud of his landscape garden mainly composed of rhododendron, of which he was considered to be one of the greatest connoisseurs in the world. A talented musician, when at home he rarely retired to bed without a few minutes with his violin.

A great raconteur, he was ever a welcome face where sportsmen foregathered, generous to a fault, a true friend and a very great supporter of the English Springer Club. Many other organisations will have real cause to regret his passing. He is mourned by all who had the privilege of his friendship, who are certainly never likely to forget a fine personality.

Standard of Points of the English Springer Spaniel

THE ENGLISH SPRINGER is the oldest of our Sporting Gundogs and the taproot from which all of our sporting land spaniels (Clumbers excepted) have been evolved. It was originally used for the purpose of finding and springing game for the net, falcon or greyhound, but at the present time it is used entirely to find, flush and retrieve game for the gun. The breed is of ancient and pure origin and should be kept as such.

The general appearance of the modern Springer is that of a symmetrical, compact, strong, upstanding, merry and active dog, built for endurance and activity. He is the highest on the leg and raciest of build of all land spaniels.

The following are the descriptive points of the English Springer Spaniel :

HEAD

The skull should be of medium length and fairly broad and slightly rounded, rising from the foreface, making a brow or stop, divided by a fluting between the eyes gradually dying away along the forehead towards the occiput bone, which should not be peaked.

The cheeks should be flat, that is not rounded or full. The foreface should be of proportionate length to the skull, fairly broad and deep without being coarse, well chiselled below the eyes, fairly deep and square in flew, but not exaggerated to such an extent as would interfere with comfort when retrieving. Nostrils well developed, underjaw strong and level mouth, that is neither over nor under shot.

EYE

The eye should be neither too full nor too small but of medium size, not prominent nor sunken but well set in (not showing haw) of an alert, kind expression. A mouse-like eye without expression is objectionable, as also is a light eye. The colour should be dark hazel.

EARS

The ears should be lobular in shape, set close to the head, of good length and width, but not exaggerated. The correct set should be in a line with the eye.

NECK

The neck should be strong and muscular, of nice length and free from throatiness, well set in the shoulders, nicely arched and tapering towards the head—this giving great activity and speed. A ewe neck is objectionable.

BODY

The body should be strong and of proportionate length, neither too long nor too short, the chest deep and well developed with plenty of heart and lung room, well sprung ribs, loins muscular and strong with slight arch and well coupled, thighs broad and muscular and well developed.

STERN

The stern should be low and never carried above the level of the back, well feathered and with a lively action.

FORELEGS

The forelegs should be straight and nicely feathered, elbows set well to body and with proportionate substance to carry the body, strong flexible pasterns, feet tight, compact, and well rounded with strong full pads.

HINDLEGS

The hindlegs should be well let down from hip to hocks. Stifles and hocks moderately bent, inclining neither inwards nor outwards. Coarseness of hocks objectionable.

MOVEMENT

The Springer gait is strictly his own. His forelegs should swing straight forward from the shoulder, throwing the feet well forward in an easy and free manner, not a paddle nor choppy terrier-like stride. His hocks should drive well under his body, following in a line with his forelegs. At slow movement many Springers have a pacing stride typical of the breed.

COAT

The coat should be close, straight, and weather resisting without being coarse.

COLOUR

Any recognised land spaniel colour is acceptable, but liver and white, black and white, or either of these colours with tan markings preferred.

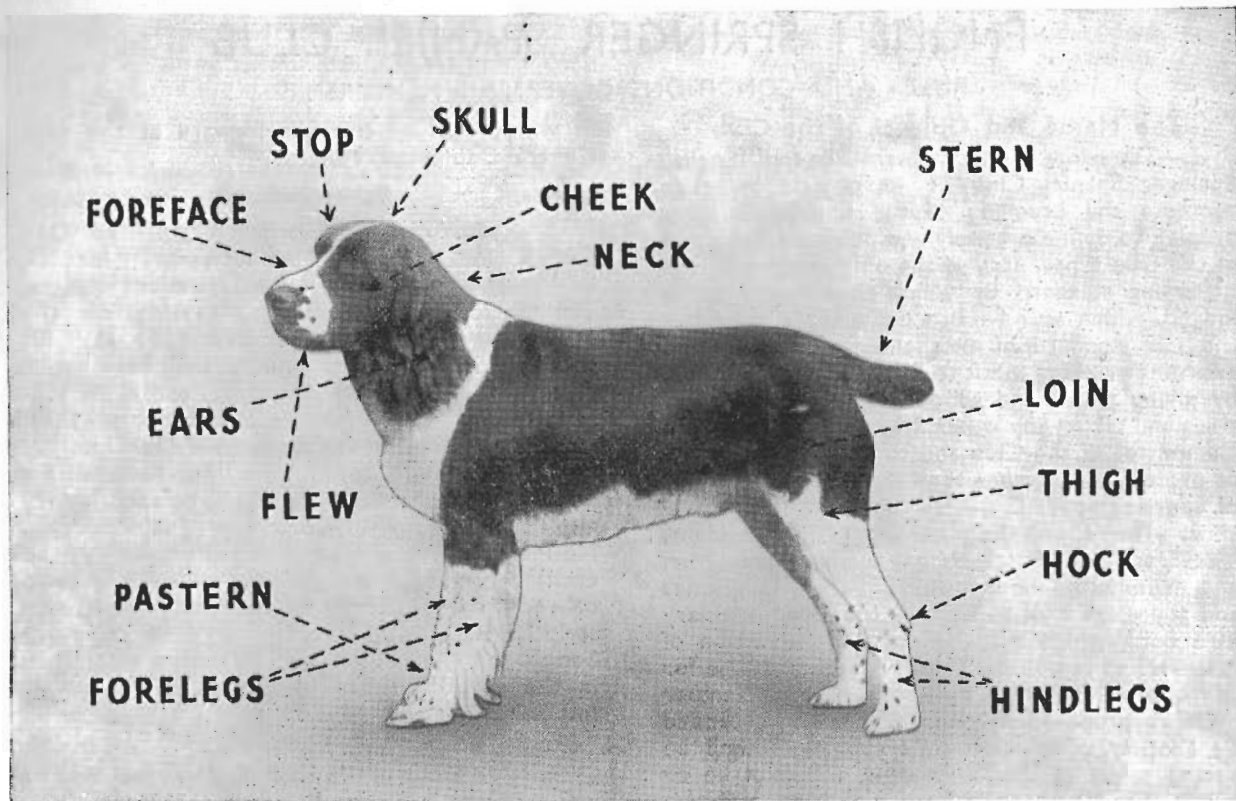
HEIGHT

The approximate height should be 20 inches.

WEIGHT

The approximate weight should be 50 lb.

The above are the revised standard of points of the English Springer Spaniel approved by The English Springer Spaniel Club of England, The Spaniel Club of England, The English Springer Spaniel Club of Scotland, and the Spaniel Club of Scotland, May 16th, 1934.

ENGLISH SPRINGER SPANIEL CLUB

RULES AND CONDITIONS GOVERNING MEMBERSHIP

The Name and Objects of the Club

1.—The name of the Club shall be the "English Springer Spaniel Club"; its objects being to promote the breeding of the English Springer Spaniel, to define precisely and publish a definition of the true types, etc., as the only recognised and unvarying standard by which they ought to be judged, which may be also uniformly accepted as the sole standard of excellence in breeding and awarding prizes of merit to English Springers; and by giving prizes and supporting shows and field trials and taking any other steps approved by the Committee of the Club and to do all in its power to protect and advance the interest in this variety of Sporting Spaniel.

2.—The Club shall consist of a President, Vice-Presidents, Hon. Secretary and Hon. Treasurer, and an unlimited number of Members, whose names and addresses shall be kept by the Hon. Secretary in a book which shall be open to inspection of Members at reasonable times. Each candidate for admission either as a Member or Hon. Member must be proposed by one Member and seconded by another. The election of Members shall be vested solely in the Committee and shall be by ballot, five Members to form a quorum, and two black balls to exclude. The election of new Members may also be by post ballot, each Member of the Committee being given the names of the new Member, together with his proposer and seconder, and if no objection is made to the Hon. Secretary within seven days of this notification the Member shall be deemed to be elected, confirmation

of which shall be brought forward at the next General Committee Meeting.

Subscriptions

3.—The Annual Subscription shall be One Guinea for ordinary Members, and for all Ex-Gamekeeper and Professional Handler Members, Ten Shillings and Sixpence, payable on the 1st January. Any Member failing to pay his subscription by the 31st January, shall have notice given him by the Hon. Secretary, and if his subscription is twelve months in arrear he shall, *ipso facto*, cease to be a Member of the Club, but may be reinstated at any time by the committee, on furnishing what they consider to be a satisfactory explanation, and paying all arrears of subscriptions. No Member whose subscription is unpaid shall be entitled to vote at any Meeting or win any prize offered by the Club. As the payment of subscription will entitle a Member to enjoy every benefit the Club can impart, so is his acquiescence in the rules furnished to him hereby distinctly implied.

Management

4.—The affairs of the Club shall be conducted by a Committee in accordance with the Rules of the Club. The Committee shall consist of not more than twelve members, and of the President, Chairman, Hon. Secretary, and Hon. Treasurer, and subject to Rules, they shall hold office from the date of an Annual Meeting until the date of the following Annual Meeting, and shall be eligible for re-election.

Powers of a Committee

5.—The property and management of the Club shall be vested in the Committee jointly who shall have power at any time to call a General Meeting of the Club, to arbitrate in disputed matters, to elect Members as aforesaid, to vote prizes or subscriptions to any Show or Field Trial Meeting, to appoint Sub-Committees and to carry on the general business of the Club.

6.—The Committee shall have power to deal with any question which may arise and is not provided for by the Rules, and to fill any vacancies occurring in their number between General Meetings or arising under Rule 18. At the commencement of every Meeting the Minutes of the preceding similar Meeting shall be read, approved, and confirmed. At least seven days' notice shall be sent of every Meeting, together with an agenda of business to be transacted, unless in case of emergency at a Field Trial Meeting.

7.—The Committee shall have power to call an Extraordinary General Meeting whenever they think it desirable, and the Hon. Secretary shall be bound to call an Extraordinary General Meeting at any time should he be required to do so in writing by the President or by not less than ten per cent. of the Members, giving Members seven days' notice of such Meeting. At an Extraordinary General Meeting, the business before the Meeting shall be intimated in the notice and be confined thereto.

General Meetings

8.—The Annual Meetings shall be held early in each year at a date to be fixed by the Committee and a notice of the Meeting with agenda shall be sent to each Member at least fourteen days prior

to the date of the Meeting. The President, Vice-Presidents, Chairman, Hon. Secretary, Hon. Treasurer, for the ensuing year shall be elected at each Annual Meeting. One-third of the Members elected on the Committee and consisting of those who have served the longest since their last election shall retire annually and their names be submitted for re-election, together with any candidates whose names have been proposed and seconded by two Members in writing to the Hon. Secretary, on or before January 1st, and the names of all candidates shall be intimated on the notice calling the Meeting, and if necessary be submitted to ballot amongst the Members attending the Meeting.

9.—No resolution passed at a General Meeting can be altered or rescinded at a subsequent General Meeting unless due notice has been given to Members and at a Meeting attended by twenty-five Members.

Annual Report

10.—An Annual Report with a Statement of the Financial position of the Club duly audited shall be drafted by the Chairman and published to the Members at least seven clear days prior to the Annual Meeting. The Financial year ends December 31st.

Rules

11.—The Rules of the Club may not be altered except at an Annual General Meeting or Special General Meeting, and such alterations shall not be brought into force until the Kennel Club has been advised and given its approval.

Conduct at Meetings

12.—No business other than that contained in the agenda shall be gone into at any General Meeting with the exception of matters of routine.

At a General Meeting the President, or in his absence, a Vice-President or the Chairman shall act as Chairman. In the absence of the Chairman at a Committee Meeting, the President shall act as Chairman, and failing him, the Members present shall elect a Chairman. At all Meetings the Chairman shall have a casting vote and his ruling shall be binding.

13.—Meetings of the Committee shall be held not less than once a year. The quorum for a Meeting of the Committee shall be five.

The Hon. Secretary in conjunction with the Chairman shall have the power to summon a Sub-Committee Meeting by giving seven days' notice.

14.—The accidental omission to give notice to any Members of any Meeting of the Club, or of the Committee, and the non-receipt by any Member of any such notice shall not affect the validity of the proceedings of such Meeting.

15.—No Prizes, Cups, or Subscriptions shall be granted to any Show or Field Trial which is not held under the Rules of the Kennel Club or Field Trial Council.

16.—The Committee shall have power to deal with all expenses incurred on behalf of the Club.

Resignation

17.—Any Member may withdraw from the Club at any time on giving notice to the Hon. Secretary, provided always that such Member shall be liable for his Subscription for the current year in which he gives notice and shall have no further claim, upon resignation taking place, on any of the property or funds belonging to the Club.

Expulsion

18.—Any Member who shall be suspended by

the Kennel Club shall, *ipso facto*, cease to be a member of the Club, and if the conduct of any Member shall, in the opinion of the Committee, be injurious or likely to be injurious to the character or interests of the Club, the Committee may, at a Meeting, the notice convening which includes as an object the consideration of the conduct of the Member, determine that a Special General Meeting of the Club shall be called for the purpose of passing a resolution to expel him. Notices of both Meetings shall be sent to the accused Member giving particulars of the complaint and advising him of the place, date, and hour that he may attend and offer an explanation. If at the Special General Meeting a resolution to expel is passed by a two-thirds majority of the Members present and voting his name shall be forthwith erased from the List of Members, and he shall thereupon cease for all purposes to be a Member of the Club, except that he may within two calendar months appeal to the Kennel Club upon and subject to such conditions as the Kennel Club may impose.

19.—Any Member who has been expelled shall forfeit all claims upon the Club.

Dissolution

20.—In the event of the Club being wound up a final Statement of Accounts will be rendered to the Kennel Club, and any assets distributed as the Committee may decide. All Challenge Cups shall be awarded to the Competitor who has won them the most times or returned to the Donor.

Appeal

21.—The Kennel Club and the Field Trial Council shall be acknowledged as the final Courts of Appeal in all matters in dispute.

22.—The Club shall not join any Federation of Societies or Clubs.
